

108.2 Schedule of permit fees: The permit fee for all work done in the Creve Coeur Fire Protection District shall be as shown in Table 112.3.1. The base amount shown is the plan review fee + \$2.00 per \$1000.00 construction cost and is subject to refunds in accordance with Section 112.2.

108.2.1 Explanation of permit fee. The regular permit fee shall include:

1. Application processing and related record keeping.
2. Complete review of construction plans and documents.
3. One rough inspection. Large commercial projects may have partial rough and re-rough inspections), as approved by the Code Official.
4. One rough re-inspection.
5. One final inspection. Large commercial projects may have partial final and re-final inspection(s), as approved by the Code Official.

6. One final re-inspection.

108.2.2 Explanation of extra inspection fee/fine. "Extra inspection fee/fine(s) shall be paid before the extra inspection is conducted".

Extra inspection fee/fine(s) shall be charged:

1. For any rough or final inspection(s) beyond what is listed in Section 108.2.1.
2. For any additional re-inspections beyond those listed in Section 108.2.1
3. When an inspection has been scheduled but cannot be conducted due to:
 - a. Building, or portion(s) of the building is locked or inaccessible,
 - b. Building or surrounding area is unsafe, as determined by the Code Official,
 - c. Fire District approved plans and/or other construction documents are not on the work site,
 - d. Work is not complete enough for an inspection or corrections have not been made as determined by the Code Official, or
 - e. The area to be inspected has been covered or concealed in any manner without first obtaining the approval of the Code Official."

108.7 Starting construction without a permit: Where any work for which a permit is required by this Code is started, or proceeded with, prior to obtaining said permit, fees as designated in the fee schedule herein shall be doubled, not to exceed \$500.00 provided that the payment of said fee shall not relieve any persons from fully complying with the requirements of this Code, nor from those other penalties prescribed herein. No further inspection will occur at the jobsite until the penalty fee has been paid at the Creve Coeur Fire Protection District Administration Office. Fees will be paid by check only.
